would like to inform you, as a client and user of the www.redwoodgroup.cz website, about the personal data privacy practices.

Processing purposes:

REDWOOD GROUP s.r.o. processes your personal data for the following purposes (everything is being processed according to the law and only the necessary and relevant information is required and used for the given purpose):

- When contacting us through the website or when starting to cooperate, we may require the basic information (name and surname or company name, home or office address, date of birth or company ID, telephone, e-mail address). Your name, surname and e-mail address may also be used to send business messages that might be interesting for you. This processing can be rejected at any time by e-mail.
- Fulfillment of obligations arising from the contract between REDWOOD GROUP s.r.o. and you (identification and contact information, property details), including the presentation of property information on the website.
- Mandatory identification and control of the client pursuant to Act No. 253/2008, On Certain Measures against Money Laundering and Terrorist Financing, as amended (identification data on identity card, type and number of identity card, state or authority of issuance, period of validity, purpose and intention of business transaction, review of sources of funds or other property).

Legal basis:

Company REDWOOD GROUP s.r.o. is authorized to process your personal data without further consent, provided that it carries out the processing necessary for the fulfillment of the legal obligations stipulated by law and for the performance of the contract with the client. The provision of personal data is a legal or contractual requirement and without such data it would not be possible to establish or continue business cooperation.

Cookies:

Recipients:

Data storage period:

Personal data will be stored during the cooperation with REDWOOD GROUP s.r.o. After the termination of cooperation REDWOOD GROUP s.r.o. will only retain personal data and documents necessary for the fulfillment of legal obligations and the protection of its legitimate interests (e.g. due to a claim or litigation) for 10 years.

Rights arising from the personal data processing:

- Right to access, correct or delete personal data (after the retention period) or to limit processing
- Right to object to processing
- Right to complain about the processing of personal data
